Mr A Pearson has offered to repair the Notice Board temporarily for a cost of £300. It was agreed not to pay for the repairs at the moment. Mr P. Bell offered to get some new wooden posts to repair the legs and to re-erect the board temporarily. Mr P. Bell also suggested approaching Henderson Plastics of Wood Norton to get a quote for a replacement in plastic.
